Alex Joshi, CFA

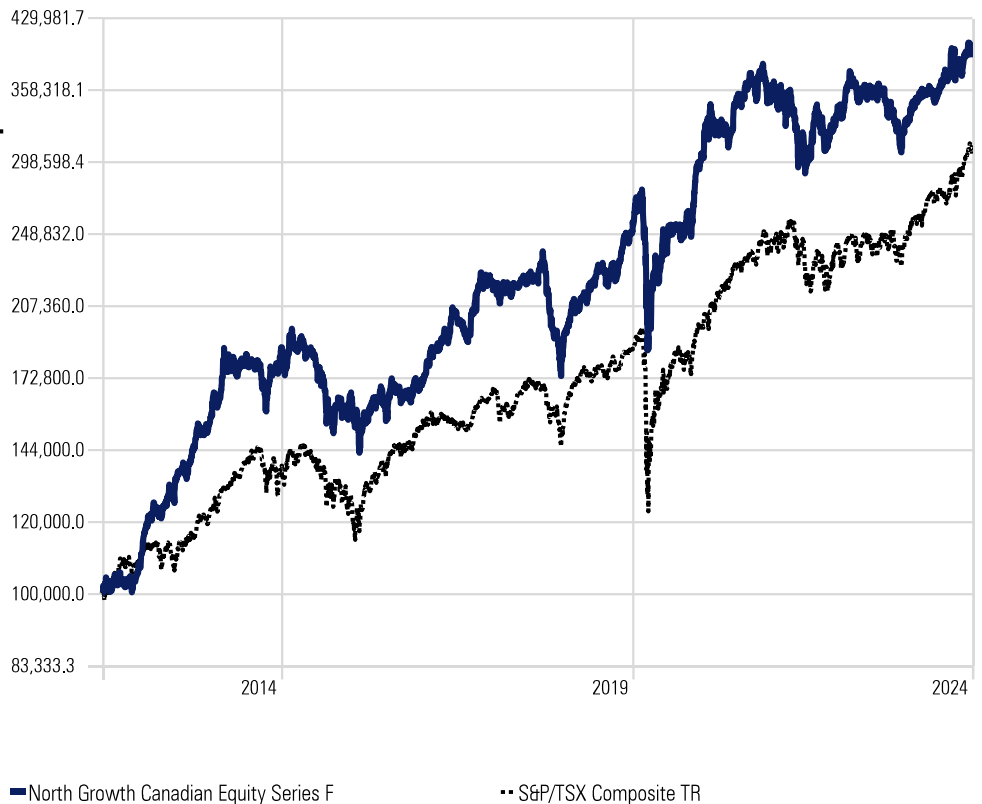
Alex is a portfolio manager. He joined the North Growth portfolio management team in June 2017.

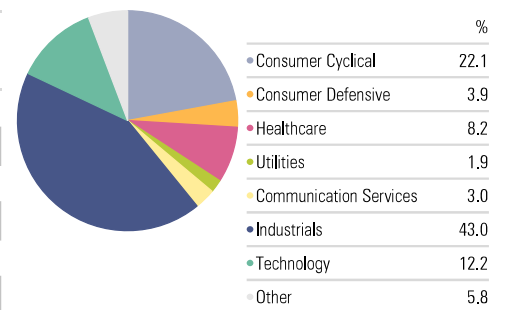

The Fund is rated for the 3 year time period among 203 funds in the category, the 5 year time period among 187 funds in the category and the 10 year time period among 149 funds in the category.
