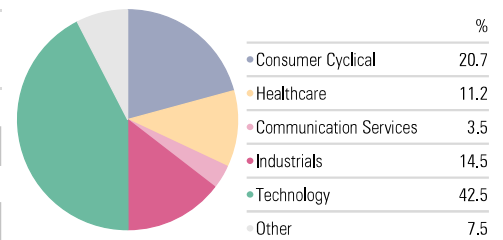

The Fund is rated for the 3 year time period among 300 funds in the category, the 5 year time period among 278 funds in the category and the 10 year time period among 212 funds in the category.
