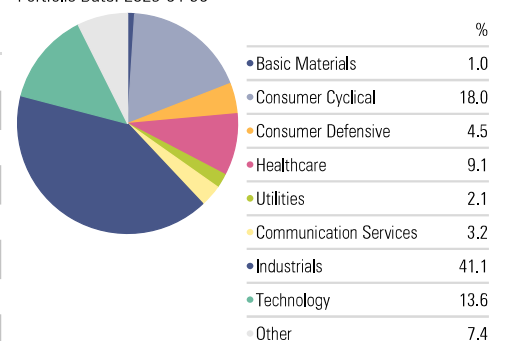

The Fund is rated for the 3 year time period among 199 funds in the category, the 5 year time period among 185 funds in the category and the 10 year time period among 147 funds in the category.
