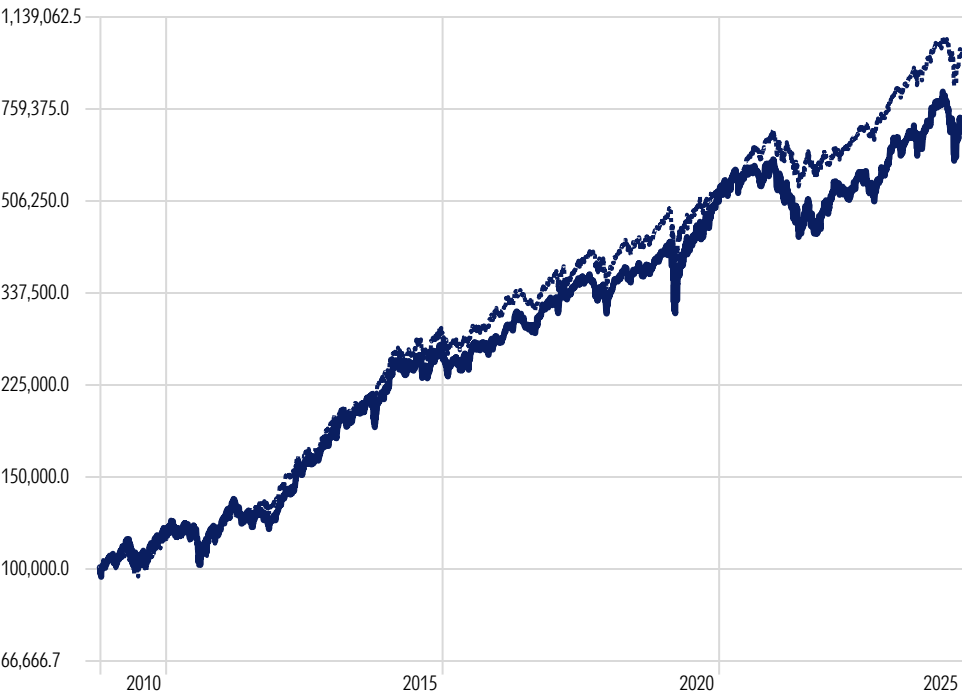
Erica Lau, CFA

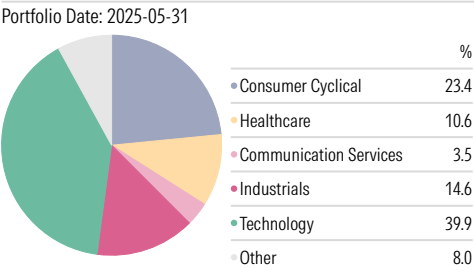
