The fundamental investment objective of the Fund is to achieve long-term growth and capital appreciation by investing primarily in equity securities of United States-based corporations.

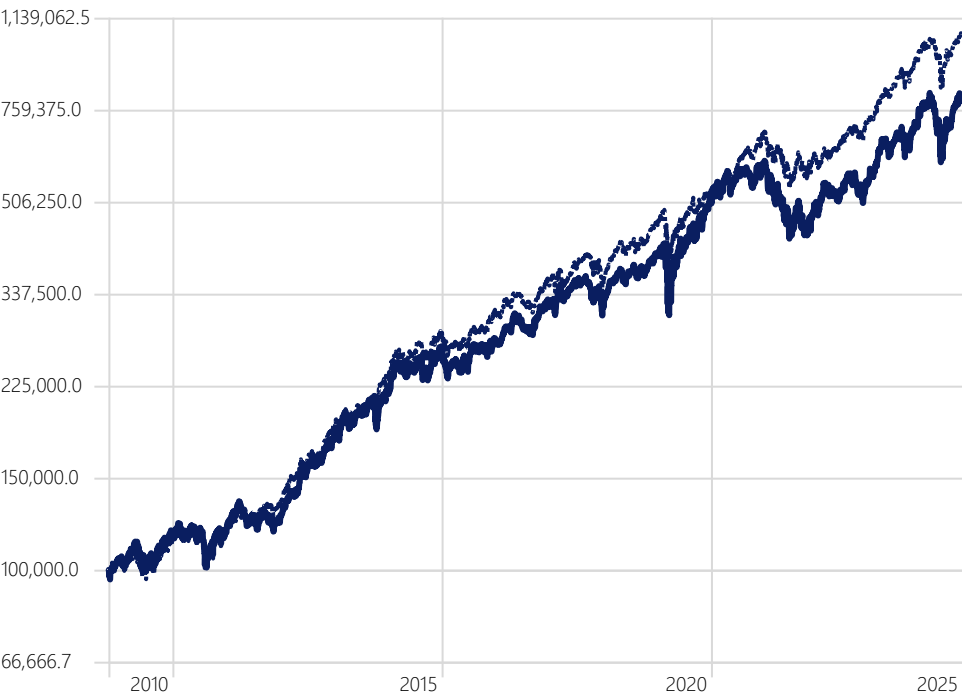

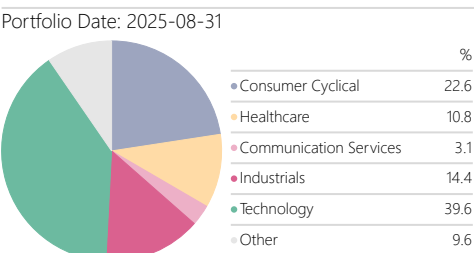

The Fund is rated for the 3 year time period among 289 funds in the category, the 5 year time period among 276 funds in the category and the 10 year time period among 212 funds in the category.
