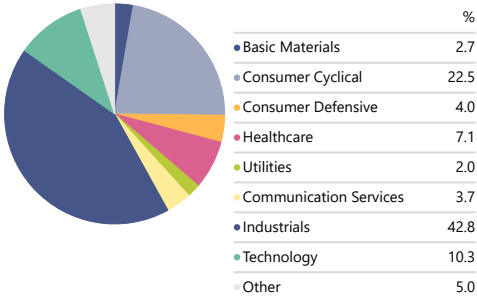

The Fund is rated for the 3 year time period among 199 funds in the category, the 5 year time period among 190 funds in the category and the 10 year time period among 151 funds in the category.
