

Funds are ranked by their Morningstar Risk-Adjusted Return scores with the top 10% of funds in a category receiving 5 stars, the next 22.5% receiving 4 stars, a fund in the middle 35% receiving 3 stars, a fund in the next 22.5% receiving 2 stars and a fund in the bottom 10% receiving 1 star. The Fund is rated for the 3 year time period among 291 funds in the category, the 5 year time period among 280 funds in the category and the 10 year time period among 216 funds in the category.
