The fundamental investment objective of the Fund is to achieve long-term growth and capital appreciation by investing primarily in equity securities of Canadian-based corporations.

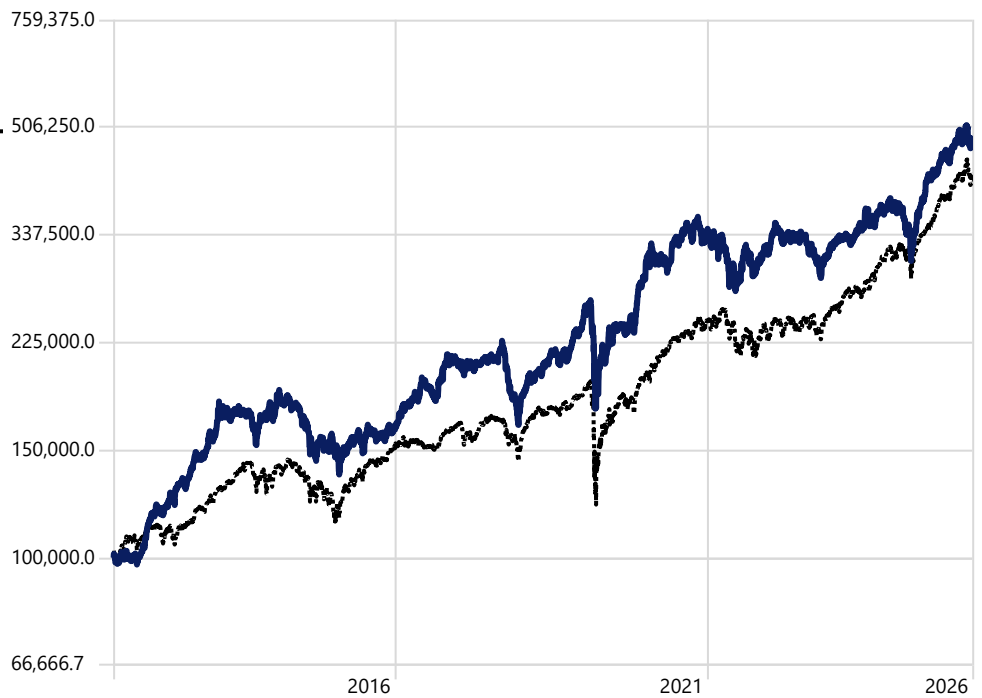

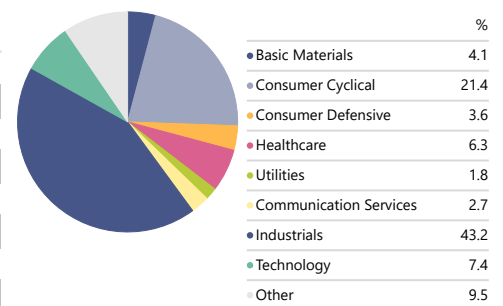

The Fund is rated for the 3 year time period among 199 funds in the category, the 5 year time period among 190 funds in the category and the 10 year time period among 151 funds in the category.
